Pavilion rentals are available for outdoor picnics and parties at Lions Club Memorial Park and Schoolhouse Brook Park. (In Season Only)

****Lions Club Memorial Park:** 30'x60' open air pavilion, picnic tables will seat 80-100 people comfortably, restroom access. Serving kitchen is available at an additional charge.

- Fees: \$50 Mandatory Deposit (refundable upon satisfactory facility inspection)
 \$50 Pavilion Rental (4 hour block of time) **Mansfield Residents**
 \$75 Pavilion Rental (4 hour block of time) **Non-Residents**
 \$20 Serving Kitchen (refrigerator, stove, sinks)

****School Brook Park (Bicentennial Pond):** 20'x30' open air pavilion, picnic tables will seat 30-40 people comfortably, additional picnic tables available on site, restroom access.

- Fees: \$20 Mandatory Deposit (refundable upon satisfactory facility inspection)
 \$20 Pavilion Rental (4 hour block of time) **Mansfield Residents**
 \$30 Pavilion Rental (4 hour block of time) **Non-Residents**

Additional fees for gate admission: (residents- weekdays \$1/person, weekends & holidays\$2/person)
(Non-residents- weekdays \$2/person, weekends & holidays\$3/person)

PROHIBITED ACTIVITIES:

- *Commercial advertising, except for temporary program sponsorship signs/banners as permitted.
- *Vending or soliciting of any type except as authorized by the Town Council.
- *Littering
- *Removal of or injury to trees, shrubs, flowers and/or other plants.
- *Drinking or possession of alcoholic beverages.
- *Molesting of birds and/or other fauna.
- *Destruction, misuse and/or defacement of park property.
- *Use or possession of explosives, firearms and/or fireworks.
- *Hunting and/or trapping.
- *Pets in swimming area.
- *All motorized vehicles except on designated public access roads and parking areas.
- *Use of the park, including parking areas, between sunset and sunrise without proper permit.
- *Disorderly conduct.
- *Golfing.
