We will not restrict the number of entries, but will reserve the right to limit them if wall space is a factor. There will be a reception for the artists in April, possibly outdoors. Artists should submit a brief artist's statement or bio on a 3x5" or 4x6" card. A small comment book to accept remarks from the public will be available on the table under the show-case, across from the receptionist's office area.
