Cannabis Sales and Cultivation-Feedback on Proposed Approach

Linda Painter, Director of Planning and Development, introduced the proposed approach on cannabis sales and cultivation and reviewed and asked for feedback on the proposed approach the Town was taking based on recent legislation. PZC adopted a nine month moratorium, which will last until March 21, 2022 however the Town Council and PZC would like to update the zoning regulations before this time. Members expressed concerns about cultivation and agreed that allowing cultivation needed more research.
