



## Kayak & Paddleboard Rental Agreement

Kayaks are available to rent at a cost of \$10 each/day or partial day of rental. Paddle Boards are \$25 per day and includes paddle, life jacket and board leash. Only one open reservation will be allowed per household. The paddle boards are 10.5 feet long and weigh about 26 pounds each. The kayaks are 10.5 feet long and weigh about 42 pounds each. After the completion of one reservation, another will be allowed. Participants are responsible for the loading, unloading, and transporting the paddle boards and kayaks to and from destination.
